## Terms and Conditions

Second Best Selected Treasures enables you to give your clothes and accessories a second life and make someone else very happy with them. Second Best Selected Treasures sells your items on a consignment basis. It's simple: you bring the items to us and we then offer them for sale for 2 months. This includes displaying your items in our store and ensuring the necessary marketing. When the item is sold you will receive 50% of the net proceeds. We do not charge any costs for all unsold items.

### Pricing, Payout and End Dates

**Second Best Selected Treasures will determine the sale price of the item** based on its own assessment of the current market situation (trends, seasons, etc.). In case of 'High End' items, the sale price will be discussed with you in advance. We reserve the right to adjust the sale price of any article, for example in response to 'end of season'.

**Second Best Selected Treasures will be offering the contributed items for sale in its store for 2 months**, unless otherwise agreed. At the end of this 2-month sales period, you have 1 month to retrieve any unsold items, and collect any proceeds from sales. For logistics reasons, this should be done by appointment. Higher sales proceeds are preferably paid out by bank transfer; smaller amounts may be paid in cash.

**As the contributor, you are responsible for monitoring the set deadlines.** An overview of the items accepted by Second Best Selected Treasures will be sent to you by email, including the applicable end date of the sales period, and the deadlines for retrieval and collection of proceeds. For this we register your correspondence data in our file.

The ownership of any items and proceeds that have not been retrieved or respectively collected while set end dates/deadlines have expired will lapse to Second Best Selected Treasures, which will then have full disposal of the goods and amounts concerned.

### What and how to offer?

**Second Best Selected Treasures has a clear vision of the clothing, shoes and accessories that it wants to sell on consignment.** That is why we carefully choose which items we want to accept for sale. We reserve the right to refuse the consignment without further explanation or to terminate it without any compensation. In the event of premature termination of the consignment by the consignor, we will charge €2.50 per item for the time and attention we have spent at the intake.

**As a guideline, the articles must fit in with the current fashion image.** In particular, Second Best Selected Treasures focuses on upper mid-market and "vintage" (i.e. 20 years or older) brands. This means that we do not accept clothing that no longer contains a label or that comes from shops/chains from the lower market segment, such as HEMA, P&C, C&A, H&M, VERA MODA, MANGO, ESPRIT, ZARA, PRIMARK, DIDI, WE etc.

**Clothing can be offered for consignment on Wednesdays, Thursdays and Fridays.** For 'High End' brands, such as Chanel, Louis Vuitton, Prada, Celine, etc., we are happy to make a 'tailor-made appointment'. In these cases, we appreciate the availability of a proof of purchase, certificate of authenticity or the original packaging.

**The articles to be brought in must be in good condition, washed clean and ironed.** That is to say: free of odors, complete (think of belts, etc.) and with a minimum of wear and traces of use (pilled sweaters, etc.).

### Liability
